Instead, SCF produced virtual and socially distanced events. Drive-by parades covered 25 neighborhood communities. Television broadcasts aired highlighting the Airshow and Hydroplane races from 2019. Radio partners helped to promote the drive-by parades allowing community engagement throughout the great King, Pierce and Snohomish counties. A series of floating concerts brought boaters of all kinds out to enjoy a day of live music and water activities.
